1. Sign and submit a request to participate, a tender (if applicable) and any other related document in respect of the aforesaid call for tenders.
2. Sign the Framework Contract, the Order Forms (Orders) and any amendment thereto.
3. Submit invoices and any other contractual documents.
4. Act as a point of contact for the SatCen as regards the services to be rendered under the Framework Contract.
5. Co-ordinate the provision of the services to the SatCen and ensure the proper administration of the Framework Contract.

By way of its signature, the authorised representative of [Economic Operator A] declares that it accepts the designation of [Economic Operator A] as Leader of the Consortium.

This power of representation shall expire when all the contractual obligations of the co-signatories towards the SatCen in connection with the services to be provided under the Framework Contract have ceased to exist.

Any modification to the present agreement / power of representation shall be subject to the SatCen's express approval.

The signed original of this power of representation shall be part of the request to participate (or the tender, if applicable) and shall form an integral part of it.
