

# PRIVACY STATEMENT ON PROCESSING OF PERSONAL DATA IN: Inclusion in Covid-19 Spanish Vaccination Strategy

#### 1. Context

The European Union Satellite Centre (SatCen) processes the personal data of a natural person in compliance with Regulation (EU) 2018/1725 on the protection of natural persons with regard to the processing of personal data by the Union institutions, bodies, offices and agencies and on the free movement of such data, and repealing Regulation (EC) No 45/2001 and Decision No 1247/2002/EC.

This privacy statement explains SatCen's policies and practices regarding its collection and use of your personal data in Inclusion in Covid-19 Spanish Vaccination Strategy procedure, and sets forth your data protection rights.

#### 2. Identity of the controller and Data Protection Officer

#### 3. Why does Administration division process such personal data?

The purpose of the processing operation is to determine the SatCen staff and family members that would be interested in being included in the Covid-19 Spanish Vaccination strategy, and communicate such interest to the Spanish authorities in charge of the implementation of the strategy.

#### 4. What personal data does Administration division process?

The SatCen will send to the Spanish Authorities (see below) your name and surname, date of birth, gender, ID number, address and phone number.

#### 5. What are the legal bases for the processing?

Providing your personal data to the SatCen is voluntary.

The processing is based on your consent. Only if you have consented, we will send your data to the Spanish authorities.

- Article 5(1)(d) – the data subject has given consent to the processing of his or her personal data for one or more specific purposes.

If you are more than 16 years old, you can give your own consent for the processing of your personal data. The consent for children with less than 16 years old must be given by the holder of parental responsibility over the child.

#### 6. Who has access to your personal data and to whom is it disclosed?

The recipients of the data are:

- SatCen Covid-19 coordinator,
- Head of Administration,
- The data will be disclosed to the Spanish Ministry of Foreign Affairs and to the Health Services of Comunidad Autonoma de Madrid.

#### 7. For how long does Administration division keep your data?

The data collected for this specific purpose will be stored for a maximum of 1 year.

#### 8. What are your rights concerning your personal data?

You have the right of access to your personal data and to relevant information concerning how we use it.

You have the right to rectify your personal data.

Under certain conditions, you have the right to ask that we delete your personal data or restrict its use.

You have the right to withdraw your consent at any time by using the contact details mentioned in this privacy statement. Please note that withdrawing your consent does not affect the lawfulness of any processing based on your consent before this consent is withdrawn.

The SatCen will consider your request, take a decision and communicate it to you.
